Limited Disclaimer/Hold Harmless Agreement**

2021 Mackinac Bridge Antique Tractor Crossing – Tractor Club Agreement

As a participating tractor club in the 14th Annual Mackinac Bridge Antique Tractor Crossing, presented by Owosso Tractor Parts on September 11, 2021, our club agrees to the following liability/disclaimer/hold harmless agreement with Owosso Tractor Repair & Parts (it's owners and employees), the Mackinac Bridge Authority, the State of Michigan and other entities listed below.

I understand that this involves risk to my organization and the participants including, but not limited to, injury due to the weather and traffic conditions and other perils associated with heights, water, bridge, vehicles, roads, buildings, and grounds. I also understand that Owosso Tractor Repair & Parts, the State of Michigan, the Mackinac Bridge Authority, it's agents and employees are not assuming any obligation regarding such risks and specifically disclaim all liability arising from such risks and any risks involved with conducting this event.

As consideration for being afforded the opportunity to conduct and/or participate in this event and activities, I agree to accept and assume 100% of the risk involved in this activity and in doing so, specifically acquit, relieve, exempt and release Owosso Tractor Repair & Parts (it's owners or employees), the State of Michigan, the Mackinac Bridge Authority, its agents and employees from any and all claims for injury, accident or damages sustained or occasioned by this activity, whether due to my own negligence, the negligence of the participants, or the negligence of Owosso Tractor Repair & Parts, the State of Michigan, the Mackinac Bridge Authority, Darrow Brothers (south staging area), City of St. Ignace, Village of Mackinaw City, Little Bear Arena, it's owners, agents, or employees.

I agree to provide general liability insurance coverage of not less than one million dollars (\$1,000,000) per occurrence providing protection against claims of bodily injury, death and property damage arising out of or in connection with the event and its activities. The maximum deductible will not exceed one thousand dollars (\$1,000). I will be also be responsible for payment of the deductible in the event of an occurrence. I will name the Mackinac Bridge Authority and Owosso Tractor Repair & Parts as additional insured on liability insurance coverage during the event. A copy of the Accord form insurance document will be provided to Owosso Tractor Repair & Parts prior to the event.

I also indemnify, hold harmless and accept all responsibility, and will defend Owosso Tractor Repair & Parts, the State of Michigan, the Mackinac Bridge Authority, it's agents and employees from any liability of damages for injury to person(s) or property occasioned by any negligence by me or the participants of my club in connection with this event and it's activities.
